### **SUPERINTENDENT'S REPORT**

Dr. Buck announced that Roosevelt Middle School's Mr. Lynn Johnson was selected as Middle School Athletic Director of the Year by the Iowa High School Athletic Directors Association. Dr. Buck also congratulated Washington High School's band director Mr. Jim Miller who was recognized by the Northeast Iowa Bandmasters Association as the 2018 Karl King Distinguished Service Award recipient. Dr. Buck stated that he wants to take a moment to acknowledge that while we recognize a few individuals from time to time through his Superintendent's Report, he is aware that there are others who may receive awards and recognitions of which he's unaware. "The bottom line is that if you're looking for a team of highly qualified, hardworking, and passionate professionals – you can find that with the Cedar Rapids Community School District. So, thank you to all who are doing this difficult and important work every day." He went on to share a few highlights of our students and staff events: Jackson Elementary held their 3<sup>rd</sup> annual Jackson Day of Service by participating in service activities such as raking leaves for neighbors or collecting supplies for organizations including Waypoint and Cedar Valley Humane Society; the weekend prior to Thanksgiving more than 60 students from CRCSD performed at the All-State Music Festival in Ames; and, Metro High School students and staff participated in their 44th annual "Turkey Day" feast which involves Metro students preparing a meal for staff, students, alum, and invited guests.
